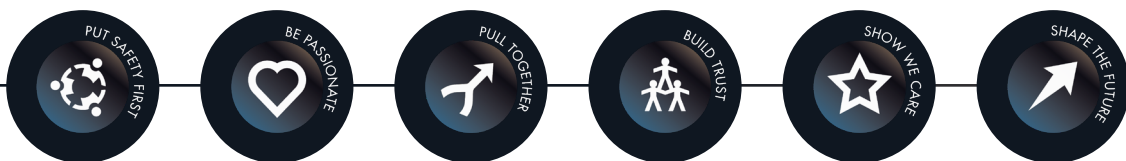

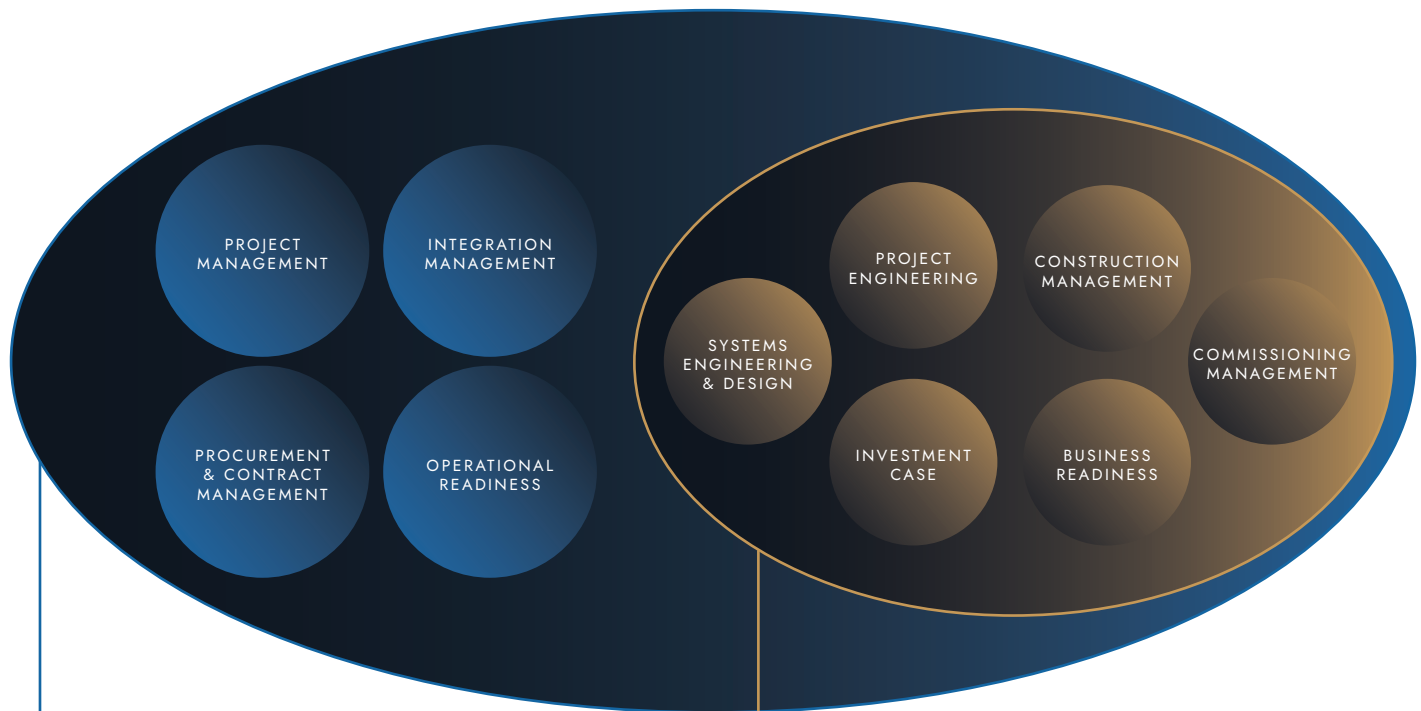

## DELIVERING EXCELLENCE ON EVERY PROJECT

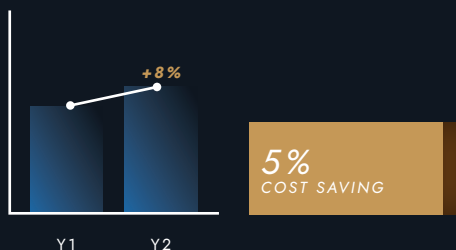
Since 2003, the Projects Division at Upstream Technology has successfully delivered over 140 Category 1–3 projects, with an exceptional track record of staying within budget—only three projects exceeded the limit by more than 5%, and even then, remained under 10%. In the past decade alone, the division has executed two major capital projects—MV SS Nujoma and MV Benguela Gem—demonstrating engineering excellence, operational efficiency, and strategic foresight.

The SS Nujoma project achieved an 8% increase in nameplate capacity within its first year, delivering 5% in cost savings and reaching completion three months ahead of schedule. Similarly, the Benguela Gem project delivered 20% additional production in its first year, came in 19% under budget, and was completed three months early, all during the challenges of COVID-19. Both projects boast an excellent safety record, reinforcing Upstream Technology's reputation for high-performance delivery and commitment to health and safety.



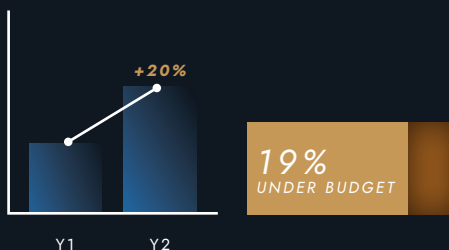
### SS NUJOMA
